## Terms and Conditions of the Camber Treffen Wheels Giveaway “Benz Patent-Motorwagen” draw competition

### 1. Official Rules & Regulations of the Camber Treffen (Wheels Prize) Contest.

Participation in the **Camber Treffen “Benz Patent-Motorwagen”** (the “Contest”) constitutes the entrant’s full and unconditional agreement and acceptance of these Official Rules and the decisions of Cum Laude Productions in accordance thereof, which are final on all matters relating to the Contest:

- 1.1) Entrants, must be 12 years of age or older, and be a South African citizen, to be eligible to win the prize.

- 1.5) At contest’s end, a Cum Laude Productions’ designated representative shall draw the grand prize winner from a random selection of all eligible entrants of the promotion.
- 1.6) The winning entrant shall be notified by public announcement at the Camber Treffen event. **The winning entrant must be present at the time of the announcement** been made and provide unconditional consent to the usage of your name and photograph by Cum Laude Productions. Failure to respond and/or consent to within-noted terms shall result in forfeiture of any and all prizes, and a subsequent entry will be drawn until such draw produces a winner who is present in person. The winning entrant must provide valid proof of South African identification, and proof of residence within South Africa within seven (7) days of the announcement been made or the prize shall be forfeited.

## 3. What Can I Win

The Grand Prize is as follows:

3.1) The winning of the set of wheels as supplied or modified by the participating sponsors and full ownership vests with the winner subject to the entire terms and conditions being met.

The approximate value of the prize package, stated in ZAR is R40 000.00.

3.2) No substitution or transfer of prizes is permitted. All taxes, fees (including compliance to road usage or by-law violations) and all other expenses and surcharges on or in relation to the prize are the sole responsibility of the prize winner. The transfer of ownership to the winner on the draw date of the award is subject to:

- 3.2.1) the winner duly complying with any fitment regulations in terms of **National Road Traffic Act of South Africa** while in possession of the prize.

## 4. Notification and Redemption

The winning entrant will be required to present his/her entry ticket for verification by our appointed auditors.

5.3) The winner agrees to the indemnity of Cum Laude Productions against any loss, damage, injury or death as result of current or future usage of the prize wheels, and the winner accepts all responsibility of the prize wheels' mechanical safety, roadworthy compliance and continuous (uninterrupted) full comprehensive insurance from the date of prize handover.

5.4) Sponsor branding or vehicle decals may not be removed from the wheels without first notifying the Cum Laude Events promoter of any accidental incident that requires removal. If branding needs to be temporarily removed for any unforeseen repairs, then the winner must provide commitment to replace such branding at their own expense within a reasonable 14 day timeframe.

5.5) Promotional events where the winner is requested to display the prize wheels will be within the borders of South Africa and will not exceed 4 hours of display time per event. The winner will be provided at least 10 days' notice of such events taking place and the winner agrees to absorb the travel cost of attending a minimum of one marketing event within the 12 month (subsequent to prize handover) qualifying period.

5.6) Should the winner not comply with any of the above terms then the prize will be forfeited and the wheels confiscated at the sole discretion of Cum Laude Productions management. In such case the draw will be voided and no further compensation or claims will be applicable for the particular concluded competition.
